

## Counter Assistant of the Year Award 2016

The Krka Counter Assistant of the Year Award recognises excellence in knowledge and service to retail customers. Nominations for the category can be made through self-nomination, by colleagues or by pharmacy business owners.

Judges will be looking to reward outstanding counter assistants, recognising those who go above and beyond their job description and make a real difference to their local community.

### **Judges will be looking for:**

- > Evidence of the individual's contribution to the pharmacy business and impact on patient care
- > Levels of excellence displayed above and beyond that expected from a counter assistant role
- > Initiatives or innovations that the individual has established or been involved with
- > Clear evidence of team working and excellent communication between the individual, their peers/colleagues and their patients and local community

### **WHO CAN ENTER?**

This category is open to all community pharmacy technicians working within both the independent and chain sectors. Applications can be through nominating an individual or yourself. Previous Irish Pharmacy Awards Counter Assistant of the Year entrants, including winners, are also welcome to submit entries.

All entries will be judged by an independent panel of experts and the winners will be announced at the Irish Pharmacy Awards on Saturday 20 May 2017 Clayton Hotel, Burlington Road.

For each award category you wish to enter you must fill in your full contact details in the spaces provided and ensure you answer all the questions. Your application must not exceed 800 words in answering questions one to four. Continue on a separate sheet if necessary.

Supporting material is permitted. Please note your supporting material does not count towards your 800 word limit.
